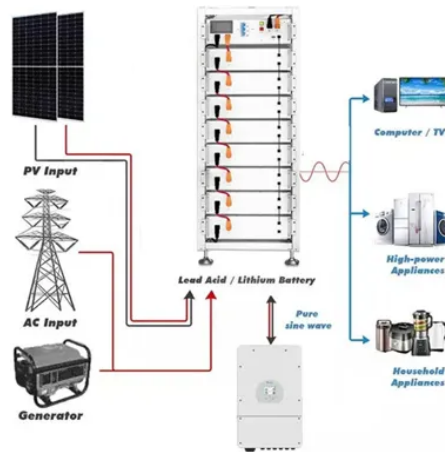


Agricultural photovoltaic support bidding



Overview

The new PNRR agri-solar tender provides approximately €800 million for agricultural photovoltaic systems, with significant incentives and tight deadlines. The strengthening of the "Agrisolar Park" measure confirms the increasingly central role of photovoltaics in the agricultural sector. Bidding for Renewable Energy tenders in Germany is extremely lucrative for companies of all sizes. Bids are made for a certain amount of capacity (to be indicated in kilowatts) which the installation is capable of delivering (bid volume). In their foreword, the two Federal Ministers Anja Karliczek and Julia Klöckner support the promising concept of combining agricultural production and renewable electricity generation on the same land. This opens the possibility to use land of higher soil quality for energy generation without necessarily creating land-use conflicts. Agri-PV tenders in Germany face delays due to missing EU state aid approval and unclear data on installed systems, stalling solar package 1 provisions.
