

Are there subsidies for energy storage projects in new zealand



Overview

The answer lies in leveraging the latest government subsidies – but only 23% of businesses know how to apply. Let's decode the hidden savings. New Zealand's Energy Efficiency & Conservation Authority (EECA) now offers up to NZ\$240,000 per project for commercial battery. Among the most prominent incentives are grants, tax rebates, and subsidies aimed at reducing the initial financial burden associated with renewable energy projects. Therefore, we are taking an appropriate role by delivering policy and regulatory certainty, and a level playing field. Renewable energy already competes with fossil fuels, in part due.
