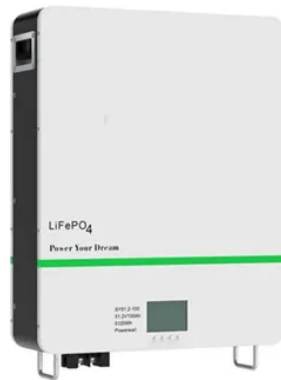


Photovoltaic panel factory export tax rebate policy



Overview

Starting 1 April 2026, value-added tax (VAT) export rebates for photovoltaic (PV) products and certain other categories will be abolished.
