The implementation of the new EU Rooftop Solar Standard could drive the installation of 150 to 200 GW of additional rooftop solar capacity in the EU between 2026 and 2030 according to SolarPower Europe. The European Union's Solar Rooftop Standard, part of the Energy Performance of Buildings Directive will speed up the uptake of solar photovoltaics and solar thermal – both on residential and non-residential buildings – and increase the possibilities of self-consumption and energy sharing. Since the 2016 edition of NFPA 1, access pathways have been required on roofs to facilitate fire service access as well as egress.
